



### Market Outlook

After a raise in October 2023, Bank Indonesia held the benchmark rate at 6% in November 2023. The exchange rate of the Rupiah was able to appreciate below Rp 15,500 per USD after nearing Rp 16,000 in the previous month. We think BI will not cut the benchmark rate first before the US central bank does. Hence, we think deposit rates should be increased while with the recent rally in money market bond that gave advantage for the money market funds to perform well.
